359. SHRI KARTAR SINGH DUGGAL: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether it is a fact that the offices of the Punjabi academy, an autonomous organisation under the Union Territory, Delhi are housed in

surroundings;

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (DR. MURLI MANOHAR JOSHI): (a) The Govt, of N.C.T. of Delhi have informed that the office of the Punjabi academy is presently situated in Community Centre, Sadar Thana Road. Although, this is a congested locality but the surroundings are not unhygienic.

(b) and (c) Delhi Govt, have further informed that presently there is not plant to accommodate all academies at one place. However, they keep on acquiring more accommodation for various offices required from time to time. Such an exercise may be helpful for allotting alternative accommodation to any of the academies experiencing difficulty.

The Working Group constituted is looking into the various aspects of the scheme in respect of graduate engineer, technician and technical (vocational) apprentices as per the terms of reference and guidelines suggested to the Working Group.
