- *49. SHRI KULDIP NAYYAR: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:
- (a) whether mid-day meal scheme has been introduced in all the schools in all the States; and if not, the reasons therefor;
- (b) the names of the States alongwith the number of schools where this scheme has not been introduced; and
 - (c) the time by when it will be introduced?

THE MINSITER OF HUMAN RESOURCE DEVELOPMENT MURLI MANOHAR JOSHI): (a) The National Programme of Nutritional Support to Primary Education, popularly known as Mid-day Meals scheme, has been introduced in all States and Union Territories since its commencement in August, 1995. According to available infromation about 9.80 crore children in primary classes ((I-V) in approximately 6.88 lakh Government Local Body and aided schools would be covered by the scheme in 1998-99.

Preservation of Srijagannath Temple, Puri

- MINISTER OF THE HUMAN RESOURCE DEVELOPMENT MURLI MANOHAR JOSHI): (a) and (b) Srijagannath Temple is a centrally protected monument since 1975. The Archaeological Survey of India has been undertaking comprehensive structural conservation and chemical preservation of the temple, as is necessary from time to time. The monument is in a good state of preservation and its upkeep is constantly under review.
- (c) During the last three years, the conservation works undertaken in the Jagannath Puri Temple Complex include the deplastering
