The gap between the demand and indigenous supply is met by imports.

- (c) During the year 1997-98, the overall capacity utilisation of the indigenous urea units recorded a significant improvement over 1996-97 from 94.2% to 105.1%.
- (d) and (e) The article in question has been brought to the notice of the Government. A suitable policy frame for promoting the installation of viable new urea capacities is under consideration.

- (b) In order to make NPPA (a newly constituted body) functional in an emphatic way, suitable accommodation with modern facilities was required. Accordingly, with the approval of the competent authority, required office accommodation was hired by NPPA itself in Jawahar Vyapar Bhavan, owned by the State Trading Corpn. of India Ltd., a Public Sector Undertaking of the Central Government.
- (c) The annual rent of the accommodation hired is Rs. 1.77.85.680/- (inclusive of taxes) as per the agreed terms and conditions and the total area hired is 7749 sq. ft.
- (d) The area in occupation of NPPA in the Jawahar Vyapar Bhawan is adequate for the present.
