Non-Acceptance of Fixed Rates in CGHS/ **CSMA Hospitals in Pune**

- (a) whether Government have received a complaint from the Bhartiya Mazdoor Sangh, Pune, that the rates for medical treatment fixed by Government for hospitals under CGHS/ CSMA are not accepted by the hospitals in

- (c) what are the reasons for non-acceptance of these rates by CGHS hospitals in Fune?

THE MINISTER OF STATE OF THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI DALITEZHrLMALAI). (a) Yes, Sir.

(b) and (c) The private Hospitals recognised under CGHS and CS(MA) Rules, 1944, in Pune are not accepting the rates for different medical procedures/ tests approved by the Government, as they are of the view that these rates are lower than the rates prevailing in the market, which have increased due to inflation" and other parameters.
