Is there any person present over here who can explain to the House as to what the position is? One bank from Kalyan has sent a letter to the Thane authorities. They want to celebrate the 50th Anniversary of Independence on the night of 14th August at 12 o'clock. They have asked whether they can hold a Flag hoisting ceremony or not. I have met the Collector, Thane. He said, "I am in favour of this proposal. But at the same time, there are no instructions whatsoever from the Government." He will approach the General Administration of the Maharashtra Government. They will approach then the Central Government. Now there are only 10 days left. The Government should issue clearcut instructions in this regard within a day or two. When the celebrations were being held on the 14th August, 1947, we were present. We are naturally reminded of that. We would like to celebrate the 50th year of our Independence like that.
