1258. DR. ALLADI P. RAJKUMAR: Will the Minister of FOOD AND CON-SUMER AFFAIRS be pleased to state:

- (a) whether Food Corporation of India has surplus staff;
 - (b) if so, the percentage thereof; and
- (c) the reasons for employing persons who have crossed superannuation age?

THE MINISTER OF STATE OF THE MINISTRY OF FOOD AND CON-SUMER AFFAIRS (SHRI RAGHUVANSH PRASAD SINGH): (a) No, Sir.

- (b) Does not arise in view of (a) above.
- (c) No employee has been given reemployment in the Food Corporation of India after attaining the age of superannuation. However, in exceptional need based cases, employees have been engaged in the Corporation on consultancy basis on fixed remuneration strictly on Government pattern to meet exigencies of work.

- 1259. SHRI KRISHNA KUMAR BIR-LA: Will the Minister of FOOD AND CONSUMER AFFAIRS be pleased to state:
- (a) whether it is a fact that the main Super Baza: in Delhi has been duped of lakhs of rupees by an Etawah based flour
- (b) if so, the details thereof stating the amount involved:
- (c) whether it is a fact that the flour mill was awarded contract by the Super Bazar in violation of the norms and practice in awarding contracts;
- (d) if so, whether Government have made any inquiry into the deal; and
- (e) if so, the outcome thereof alongwith the action taken by Government in the matter?

THE MINISTER OF STATE OF THE MINISTRY OF FOOD AND CON-SUMER AFFAIRS (SHRI RAGHUVANSH PRASAD SINGH): (a) and (b) According to information furnished by the Super Bazar, no money was spent by Super Bazar from its account on the procurement of wheat which was allotted to M/s Etawah Flour Mill, UP. The mill had deposited Rs. 1 crore to FCI by Demand Draft and had actually lifted 1149.5 M. Tonnes of wheat as against the allotment of 2,000 M. Tonnes. The mill had also deposited an amount of Rs. 40,000 as security with the Super Bazar. The Super Bazar has not suffered any financial loss on this account.

- (c) The decision to award contract to M/s Etawah Flour Mill was taken by the Purchase Committee as per the rules of the Super Bazar.
- (d) and (e) The Central Registrar of Cooperative Societies was asked to conduct an enquiry into the matter. The Enquiry Report of the Central Resistrar

has since been received. As the processing of the report involves consultation with other departments, no final decision has been taken on the recommendations by the Government.

FCI Godowns in North-Eastern Region

- (c) During 1997-98, the Food Corporation of India propose to construct godowns at Dimapur (Nagaland), Jowai (Meghalaya) and Jiribam (Manipur) with a total capacity of 16,250 MT subject to availability of funds.

The quantities of wheat and rice allotted and lifted in case of States in North-East during 1996-97 and 1997-98 are given in statement attached. [See Appendix 181 Anne-

(b) to (d) The quantity of wheat required for supply to States / UTs for PDS in North-East States is moved from Northern States of India or from outside. There have been occasions when due to movement bottlenecks, labour trouble etc., there was temporary dislocation in supplies.
