- (b) whether any expert Committee was formed to examine and report about the modernisation programme of Rourkela and Durgapur integrated steel plants;
 - (c) if so, the details of the report;
- (d) whether Rs. 10,000 Crore have been spent on modernisation of these two steel plants, and capacity utilisation of these plants has increased to the expected level; and
- (e) if not, the reasons thereof and whether an inquiry would be conducted in the whole affair and action taken against the persons responsible for the loss?

THE MINISTER OF STEEL AND THE MINISTER OF MINES (SHRI BIRENDRA PRASAD BAISHYA): (a) Yes, Sir.

- (b) to (d) An amount of Rs. 4472.85 crores on modernisation of Durgapur Steel Plant (DSP) and Rs. 3453.84 crores on modernisation of Rourkela Steel Plant (RSP) respectively have been spent by SAIL till 1996-97.
- * The modernisation programmes are in advance stages of completion in these steel plants and improvement in capacity utilisation to the envisaged level will be known on completion of the various units and their stabilisation. No Expert Committee has been formed to examine and report in this regard.
 - (e) Does not arise.

Decline in Growth Rate of Steel Production

1375. SHRI PREM CHAND GUPTA: Will the Minister of STEEL be pleased to state:

(a) whether it is a fact that the growth rate of Steel production declined sharply from 5.9% in 1995-96 to 1.6% in 1996-97; and

(b) if so, the reasons thereof?

THE MINISTER OF STEEL AND THE MINISTER OF MINES (SHRI ¹ BIRENDRA PRASAD BAISHYA): (a) No, Sir. The production of finished carbon steel reached on all time high of 22.72 million tonnes during 1996-97, recording an increase of 6.17% over the previous year.

(b) Does not arise in view of (a) above.

Total land under the control of Visakhapatnam Steel Plant

1376. SHRI YERRA NARAYANA SWAMY: Will the Minister of STEEL be pleased to state:

- (a) the total extent of land under the control of Visakhapatnam Steel Plant in Andhra Pradesh;
- (b) whether it is a fact that similar plants overseas require much less land;
- (c) whether there is any possibility of reducing the extent of V.S.P, in Andhra Pradesh; and
 - (d) if not, the reasons therefor?

THE MINISTER OF STEEL AND THE MINISTER OF MINES (SHRI BIRENDRA PRASAD BAISHYA): (a) to (d) 20485 acres of land is presently under the control of Visakhapatnam Steel Plant (VSP) in Andhra Pradesh. Land requirement for a steel plant depends on steel making capacity, the future plans and facilities provided for. Therefore no generalised comparision with steel plants abroad may be possible.

Dumping of imported steel in the company

1377. SHRI GURUDAS DAS GUPTA: SHRI J. CHITHARANJAN:

Will the Minister of STEEL be pleased to tate:

(a) whether Government have received any complaints about dumping of imported steel in the country; and

(b) if so, the details thereof and Government's reaction thereto?

THE MINISTER OF STEEL AND THE MINISTER OF MINES (SHRI BIRENDRA PRASAD BAISHYA): (a) and (b) A petition has been received on behalf of the domestic industry by the Designated Authority appointed under Customs Tariff Act, 1975 read with the rules made thereunder, alleging dumping of some finished steel products. The application is under examination by the Designated Authority for initiation of investigation.

Provision exists in the Customs Tariff Act, 1975 and rules framed thereunder to investigate cases of dumping and levy an additional customs duty, if it is established that such dumping causes material injury to the domestic industry.

Project and exports by SAIL

1378. SHRI SANJAY NIRUPAM: SHRI MUKESH R. PATEL: Will the Minister of STEEL be pleased to state:

- (a) whether the Steel Project of Steel Authority of India Ltd. (SAIL) is on decline;
- (b) if so, the details thereof and the reasons* therefor;
- (c) whether SAIL is not able to increase the export of steel produced by Bhilai Steel Plant, Bokaro Steel Plant etc.;
- (d) if so, the details thereof and the reasons therefor: and
- (e) what measures have been taken by Government to improve the export by SAIL, and the overall profit of SAIL?

THE MINISTER OF STEEL AND THE MINISTER OF MINES (SHRI BIRENDRA PRASAD BAISHYA): (a)

and (b) The profit (before tax) in SAIL in 1996-97 was Rs. 602* crores as compared to Rs. 1318.61 crores in 1995-96. During the vear 1996-97 SAIL had to face abnormal increase in input costs on account of cost escalation in coal price petroleum price, railway freight, power tariff, special custom duties etc.. The impact of these escalations is about Rs. 1000 crores while only a part of this impact could be neutralised through improvement in operational efficiencies. Other reasons, which have affected the profitability, include decline in the international prices of steel and freer imports bringing the margins under stress as also the sluggish market behaviour etc. due to which SAIL could not pass on the impact of input cost escalation to the customers.

(c) and (d) During 1996-97 SAIL exported 478.81 thousand tonnes of steel as against 406.6 thousand tonnes in 1995-96.

There Has been a quantum jump in exports in the first quarter of 1997-98. Two lakh tonnes of steel has been exported, registering a growth of about 150% - over same period last year. In addition, about 60,000 tonnes of Pig Iron were also exported in the first quarter of 1997-98 against nil exports for first quarter previous year.

(e) SAIL is taking steps on continuous hasis to improve its performance, which include modernisation and technological upgradation of its plants, improving techno-economic factors i.e. reduction in ; coke rate, energy consumption, metallic input, improvement in yield, extensive customer contact, market oriented product-mix, improvement in quality, long term relationship with customers, leadership in service and customer satisfaction, strict control and monitoring of operating costs, higher productivity and greater autonomy to field officers, etc.
