- (b) On 24.2.1997, the Joint Management Committee (JMC) of the Oman-India Fertilizer Project (OIFP) declared the consortium of Snamprogetti S.P.A., Italy and Technip S.A., France as the preferred Engineering, Procurement and Construction (EPC) Bidder for setting up OIFP on a lumpsum turn-key basis.
- (c) and (d) In its representations to Oman Oil Company S.A.O.C. (Oman Oil) and the Ministry of Chemicals & Fertilizers, the consortium of Uhde. Gmbh Germany and George Wimpey International Ltd., U.K., (Uhde) had questioned the application of the loading criteria adopted for evaluation of the variations with reference to the terms of the notice inviting tender. The representation of Uhde was considered and rejected by Oman on 13.3.1997. On 21.4.1997 Uhde was informed by the Government that the selection of preferred bidder for OIFP has been made by the project authorities after following an objective criteria for evaluation and the matter did not call for any interference by the Government. Uhde has, however, pressed its case again.

Irregularities in Pyrites, Phosphates and Chemicals Ltd., Amjhore

- (a) whether Governmnt are aware of the fact that 'Pyrites, Phosphates and Chemicals Limited Amjhore' in the district of Rohtas in Southern Bihar is running at loss and corrutpion is on high level:
 - (b) if so, the details thereof; and
- (c) Government's action against the corruption?

THE MINISTER OF CHEMICALS AND FERTILIZERS (SHRI M. ARUNACHALAM): (a) to (c) The Single Superphosphate (SSP) unit of Pyrities, Phosphates & Chemicals Ltd. (PPCL) at Amihore, which follows the high cost pyrities route for the production of sulphuric acid used in the manufacture of SSP, has been incurring losses since its inception. The details of the losses incurred since 1990-91 are as under:

THE MINISTER OF CHEMICALS (SHRI M. **FERTILIZERS** AND ARUNACHALAM): (a) and (b) Presently, there is no proposal for arranging the imports of phosphatic and Government potassic fertilizers on account. The imports of these fertilizers, which are de-canalised, are being made freely on trade account.
