## Role of SIDBI in Promotion of SSI Sector

2238. SHRI MOHD. SALIM: Will the Minister of FINANCE be pleased to state:

- (a) the role played by Small Industries Development Bank of India (SIDBI) in the promotion of SSI Sector in the country; and
- (b) the number of units established revived with the loan provided by SIDBI in the S.ates during the last three years, State-wise?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHERI SAT-PAL MAHARAJ): (a) The Small Industries Development Bank of India (SIDBI) has been set up to function as he principal financing institutions for promotion, financing and development of industry in the small scale sector and to coordinate the functions of institutions engaged in similar activities.

In order to fulfil the assigned role, SIDBI implements a number of schemes for providing financial assistance, extension support and undertaking promotional aspects of industries in the small scale sector.

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI SAT. PAL MAHARAJ): (a) and (b) As per the latest figures collected by he Ministry of Labour, the arrears of wages and statutory dues of the Central public sector undertakings to their workers are of the order of Rs. 605 crore. Government is seized of the issue regarding payment of the arrear dues.
