(b) and (c) Some cases of touts and antisocial elements indulging in cornering of berths/scats have come to notice of Railways. Regular and surprise checks are conducted by the Commercial and Vigilance departments with the assistance of Railway Protection Force' Government Railway Police styff to check the activities of touts and other antisocial elements in and around the reservation offices. The drives against touts were intensified and during Ann! to June, 1997, 174 touts were apprehended by Northern Railway. Action has been taken against them under the provisions of Railway Act. 1989. Railway staff found involved in or abetting such activities are severely taken up for penal
