383. SHRI GOVINDRAM MIRI: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether his attention has been drawn towards a news-item, captioned "Bid to flout High Court order on school quota" which appeared in the Economic Times (New Delhi) dated the 14th May, 1997; and
- (b) if so, Government's reaction thereto?

THE MINSITER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIMUHI RAM SAIKIA): (a) yes, Sir.

(b) The Government has not flouted any orders of the Court.

## Bungling in the name of Women and Child Welfare

- 384. SHRI O. P. KOHLI: Will the Minister of HUMAN RESOURCE DE-VELOPMENT be pleased to refer to the answer to Unstarred Question 2550 given in the Rajya Sabha on 25th August, 1995 and state:
- (a) whether the enquiry has since been held and report submitted;
- (b) if so, the outcome of the enquiry; and
  - (c) the action taken in the matter?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI S. R. BOMMAI): (a) The matter was enquired in consustation with the Ministry of Non-Conventional Energy Sources, Delhi Government, CSWB, Rashtriya Mahila Kosh etc. The comments from All India Women's Confernece on the alleged irregularities were also examined.

- (b) No allegation could be sub-stantiated from the information received from the different Departments/Ministries dealing with Women and Child Development Programmes.
  - (c) Does not arise.

## Private participation in National Culture

385. SHRI SANJAY DALMIA: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether Government's attention has been drawn to the news-item captioned "National Culture Fund will boost private participation" which appeared in the Times of India dated March 30, 1997;
- (b) whether Government have allowed the private sector participation in the cultural sector;
- (c) if so, the aims and objectives alongwith the amount earmarked in this regard;
- (d) the impact of participation of private sector on the cultural aspects; and
- (e) the steps taken to check the dilution of the Indian culture by privatisation?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI S. R. BOMMAI): (a) The Government of India have set up a National Culture Fund (NCF) in terms of a Notification published in the Gazette of India Extraordinary dated 28.11.96. Copies of the Notification are already available in the Parliament Library.
