THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): (a) to (d) The NCERT textbooks and the National Curriculum for Prinary and Secondary Education—a framework (December, 1985) had emphasised Value education at Primary and Secondary levels. the States, through their textbook corporations and

the examining boards, were expected to implement these. The philosophy of NCERT has been to integrate values in textbooks of different subjects at different grades of the school stages, rather than making it a subject of teaching. This is because the values sought to be inculcated transgress different subject areas. For example, many of universal values are sought to be inculcated among learners like small family norms, human rights, gender equity etc., fall in the domain of social studies, whereas conservation of nature, natural resources, scientific temper, like exactitude truthful observation and objective recording of data, etc. fall in the domain of sciences. Language too incorporates human values like truth, honesty, pity, peaceful coexistence,
