SAIL consolidates its financial results on half yearly and annual basis. Hence, profit position will be know after expiry of six months/year of the current financial year.

(b) During the years 1994-95, 1995-96 and 1996-97 SAIL imported "Low Ash Metallurgical Coking Coal" of prime quality as a quantitative and qualitative supplement to the indigenous coking coal from Australia, New Zealand and China to meet the total requirement of Steel Plants.
