Qualcomm failed to meet the specified parameters of TEC

- 302. SHRI SATISH AGARWAL: Will the Minister of COMMUNICATIONS be pleased to state:
- (a) whether it is a fact that as per the caption "DOT plans hit as Qualcomm fails to pass TEC test" which appeared in the Financial Express, dated the 1st May, 1997 the Qulacomm has failed to meet all the specified parameters to TEC;
- (b) whether it is also a fact that MTNL Delhi has launched telephones based on WLL system of Qualcomm even without meeting all test of TEC;
