Seizure of Large Quantity of Explosives and Bombs in Chennai and Central Gov- ernment & Assistance to the State Gov- ernment in this Regard

SHRI S. PETER ALPHONSE (Tamil Nadu): Mr. Vice-Chairman, Sir, I thank you for giving me this opportunity. The Chennai Police, in a commando operation conducted on a house on the city outskirts on 10th March, seized a large quantity of powerful explosives. They also arrested two militants, who were supposed to be involved in the manufacturing of those explosives. The seized material was sufficient to set the entire city on fire and could easily bring down multistoreyed buildings. It is an astonishing fact that the explosive material was concealed in goods of daily use like cycle-bell, motor-horn, tiffin-carrier and plastic tumblers. They recovered eighty-eight such items. The intention of the conspirators appeared to be to strike terror in the city on the lines of the blasts that went off in Mumbai and the killing of innocent people in Delhi through transistor-bombs. Sir through you, I would like to congratulate the Chennai Police on

their timely detection of the conspiracy, and on their swift and meticulous action in recovering the explosive materials from the culprits.

Tamil Nadu has been a land of peace, tranquility and communal harmony. What had happened in Chennai is not an isolated incident. It is a continuation of Mumbai and Delhi, where innocent people were killed in hundreds. This kind of bomb explosions are not new to Tamil Nadu.

It is also pertinent to note that the seized explosive materials were similar to those that went off at the Hindu Munnani Office at Chindadripet, at the RSS Office at Chetpet, at the film director, Mr. Mani Ratnam's house in Alwarpet, at the hotel 'Light of Asia' in Broadway, at 'Lucky' in Mannadi, and 'Imperial' in Egmore.

Unlike what had happened during the AIDMK regime, this time, the State Government was very alert and they did a commendable job.

SHRI R. MARGABANDU (Tamil Nadu): Very good.

SHRI PETER S. ALPHONSE: Let me complete it. The State Government did a commendable job in preventing any explosion. What had happened in Chennai...

SHRI R. MARGABANDU: How did they come?

SHRI PETER S. ALPHONSE: Sir, what had happened in Chennai is a part of the national conspiracy to destabilise our nation. It seems to me to be a continuation of the explosions in Mumbai and Delhi. I apprehend that these militants who are bent upon killing innocent people may target other State Capitals like Bangalore, Hyderabad and Calcutta.

Since this conspiracy has got an all-India ramification, the Union Home Ministry should come forward to help the Tamil Nadu Government by providing more financial assistance to the Tamil

Nadu Police, as well as assist in the investigation in all possible ways. Also, all people, irrespective of their religion should come forward to fight terrorism.

I suspect a failure on the part of the Central intelligence agencies who were not keeping track of these dreadful militants. Therefore, I would suggest that the Central intelligence agencies should be asked to file a detailed report regarding the movement of such dreadful militants.

SHRI V. NARAYANASAMY (Pondicherry): Mr. Vice-Chairman, Sir, I would like to say a few words on this. *(Interruptions)*

SHRI R.K. KUMAR (Tamil Nadu): Sir, I also want to associate with this. *(Interruptions)*

THE VICE-CHAIRMAN (SHRI AJIT P.K. JOGI): So many of you want to associate? All right. Mr. Narayanasamy, please. Please associate just in one sentence.

SHRI V. NARAYANASAMY: Two minutes, Sir.

THE VICE-CHAIRMAN (SHRI AJIT P.K. JOGI): One sentence.

SHRI V. NARAYANASAMY: At least, one minute, Sir.

Sir, recently, in Coimbatore, and also in Tirunelveli District, in the Kanyakumari area, religious leaders were killed. Apart from this earlier, there was a bomb blast in the Meenakshi Amman Temple, Madurai.

THE VICE-CHAIRMAN (SHRI AJIT P.K. JOGI): All these details he has given.

SHRI V. NARAYANASAMY: He has given some other details.

THE VICE-CHAIRMAN (SHRI AJIT P.K. JOGI): He has given the details.

SHRI V. NARAYANASAMY: The bomb blast that took place is a very serious matter, in the sense that...

SHRI PETER S. ALPHONSE: It was not a bomb blast. There was a recovery of explosives.

SHRI V. NARAYANASAMY: Earlier, bomb blasts took place in Mumbai, Calcutta and Delhi. This culture is now coming to Tamil Nadu also.

THE VICE-CHAIRMAN (SHRI AJIT P.K. JOGI): We are talking of Chennai; Tamil Nadu.

SHRI V. NARAYANASAMY: That is what I am saying, Sir. This culture is coming now to Tamil Nadu also. These explosives which were recovered by the Tamil Nadu Police gelatine and other things—were concealed in household items like tiffin boxes, etc. The recovery of such a huge quantity of explosives in Chennai itself clearly shows that terrorist activity is on the rise in Tamil Nadu. The reason is, when the DMK was in power in Tamil Nadu earlier, the militants were given protection by that Government. Now it is being repeated.

SHRI R. MARGABANDU: Yes. (*Interruptions*)

SHRI V.P. DURAISAMY (Tamil Nadu): Sir, he is politicising the issue. (*Interruptions*)

SHRI R.K. KUMAR: He is not politicising. He does not belong to the AIADMK. Let him speak. (*Interruptions*)

SHRI V. NARAYANASAMY: Therefore, I urge upon the Union Home Minister... (*Interruptions*)

THE VICE-CHAIRMAN: (SHRI AJIT P.K. JOGI): Please wind up, Mr. Narayanasamy.

SHRI V.P. DURAISAMY: He is giving a political colour. (*Interruptions*)

SHRI V. NARAYANASAMY: I urge upon the Home Minister to come to this august House and make a statement on the law and order situation that is prevailing in Tamil Nadu as on date. (*Interruptions*)

THE VICE-CHAIRMAN (SHRI AJIT P.K. JOGI): Shri N. Thalavai Sundaram, please.

SHRI N. THALAVI SUNDARAM (Tamil Nadu): Thank you, Sir, for giving me the opportunity to speak.
