Doordarshan. Regarding India-based satellite channels, these are beamed from outside the country and thus, fall outside the ambit of Indian laws.

(c) To made the Cinematograph Act, 1952 more effective, a Bill was introduced in the Rajya Sabha on 18.8.92. The Bill is expected to come up for discussion in the Rajya Sabha in the current session.
