THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI N.V.N. SOMU): (a) Yes, Sir.

(b) Action has been initiated by the authorities concerned under Cantonments Act, 1924 as well as Public Premises (Eviction of Unauthorised Occupants) Act, 1971.

#### **Comprehensive approach to National Security Problems**

1218. DR. MOHAN BABU: Will the Minister of DEFENCE be pleased to state the long term comprehensive approach proposed to the national security problems of the country?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI N.V.N. SOMU): Government continually assess possible threats to national security and ensure the maintenance of adequate defence preparedness.

#### **Decision Making Committee on defence matters**

1219. SHRI K.M. SAIFULLAH: Will the Minister of DEFENCE be pleased to state:

(a) whether there is an apex Committee for decision making on defence matters;

(b) if so, constitution thereof; and

(c) in which year this Committee was constituted and the number of times it has met since its constitution?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI N.V.N. SOMU): (a) to (c) The National Security Council was constituted on 24th August, 1990, under the Chairmanship of the Prime Minister. The Ministers of Defence, Finance, Home Affairs and External Affairs are Members of this Council. It is a forum to evolve an integrated approach to national security policy having regard to the developing external situation in the political, military and

economic fields as well as the prevailing domestic situation. It met on 5th October, 1990.

#### **Blackmarketing of petrol by armed forces' drivers**

(b) if so, the details thereof and steps taken to prevent blackmarketing and pilferage of petrol; and

(c) if no steps have been taken, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI N.V.N. SOMU): (a) to (c) Yes, Sir. In the Armed Forces, a fool-proof mechanism exists to check theft of Petrol which is being enforced strictly.
