SPG Protection to Women VIPs

1266. SHRI RAM GOPAL YADAV: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether women VIPs enjoying SPG protection will continue to get such protection even after marriage;
 - (b) if so, the reasons therefor; and
- (c) the steps proposed to stop avoidable expenditure in such coverage/protection?

THE MINISTER OF STATE IN THE OF HOME **AFFAIRS** MINISTRY (SHRI MOHD. MAQBOOL DAR): (a) to (c) As per provisions of the SPG Act, as amended, SPG is responsible for providing 'proximate security' to the Prime Minister and the members of his immediate family as also the former Prime Ministers and members of their immediate families for a period of 10 years from the date of demission of their office. The immediate family members include wife, husband, children and parents. Therefore, the lady VIPs enjoying SPG protection will continue to get such protection even after marriage. There is no proposal to make any amendment in the SPG Act at present.
