works and for effective funding of the projects in the flood sector besides mobilising youths for the purpose. Secretary (Irrigation), Government of Andhra Pradesh is a Member of the Southern Regional Task Force. The final report of the Task Force is expected to suggest comprehensive solution to the flood problem of each State.

Sinking of artesian wells in Tamil Nadi

- 1319. SHRI S. NIRAIKULATHAN: Will the Minister of WATER RESOURCES be pleased to state:
- (a) whether Government would consid er sinking artesian wells in completely dry and backward districts like Ramanathapuram, Tamil Nadu to pro vide water for drinking and irrigation;
- (b) whether Government have any programme for such dry regions to enable farmers to cultivate their land lying bar ren now; and
- (c) if not, whether Government would consider a scheme for developing the region?

THE MINISTER OF WATER RE-SOURCE (SHRI JANESHWAR MISHRA): (a) Sinking of wells for drinking water and irrigation is planned, financed and implemented by the State Government. However, in its programme of scientific exploration of ground water the Central Ground Water Board has identified an artesian belt in an area of 4600 sq. kilometers in Tamil Nadu and Pondicherry, including Ramanthapuram district.

(b) and (c) No, Sir. Development of ground water for various purposes, including sinking of artesian wells for cultivation in dry regions, is- the responsbility of State Governments. However, the district of Ramanthapuram in Tamil Nadu has been covered under the Drought Prone Area Programme being imlemented by the Ministry of Rural lemented by the Ministry of Rural lemented by-he-lipment of such areas is taken up on vatershed project basis. A Comprehen-

sive Watershed Development Project supported by Danish International Development Agency was also launched in the district of Ramanthapuram in the year 1994 with the objective to check further land degradation and develop sustainable and cost effective system for utilisation of land resources and create long term op-portunities for employment of local com-mittees. The main contents of the project include development of agro-forestry, dry-land horticulture system and conser-vation of rain water.
