

**Waiting list of General Category subscribers in Punjab, Uttar Pradesh, Bihar and Haryana**

1188 SHRI MOHINDAR SINGH KALYAN: Will the Minister of COMMUNICATIONS be pleased to state:

(a) the details as on 1st February, 1997 of the waiting list of the general category subscribers/applicants in the States of Punjab, Uttar Pradesh, Bihar and Haryana;

(b) the details in regard to the telephone connections provided during the first nine months of the current financial year; and

(c) the steps being taken by Government in this regard?

THE MINISTER OF COMMUNICATIONS (SHRI BENI PRASAD VARMA): (a) The details of the waiting list of "general category" subscribers as on 1st February, 97 in Punjab, U.P., Bihar, and Haryana are given below:

**Demand and Supply of Telephones**

1189. SHRI MOHINDAR SINGH KALYAN: Will the Minister of COMMUNICATIONS be pleased to state:

(a) the month-wise and year-wise details of demand and supply of telephone connections at present in the country, State-wise;

(b) whether it is a fact that there is a wide gap between the demand and supply of telephone connections in the country; and

(c) if so, the reasons therefor and the measures being taken by Government in this regard?

THE MINISTER OF COMMUNICATIONS (SHRI BENI PRASAD VARMA): (a) Details of demand and supply of telephone connections, State-wise, and month-wise at present (April % to January 97) is given in Annexure and the same year-wise for the last three years is also given in Annexure. [See Appendix 180 Annexure No. 29]

(c) and (c) Growth rate for telephone demand in the country steadily increased from 9.24% (1993-94) to 19.31% (1995-96). The resource allocation and availability of other infrastructure are being stepped up during Ninth Five Year Plan to improve the supply of telephone connections in the country.

**Construction of Postal Building in Kutch District**
