(c) At the Central level, action is taken to facilitate coordination of the anti-naxalite operations of different states and to improve flow of information useful for control of naxalite activities among the States. Further, help is being provided to the State Governments in terms of financial assistance for modernisation of police, supply of improved weapons, deployment of para-military forces etc. In certain special circumstances, financial assistance has also been given to some of the affected States over and above the on-going allocations for modernisation of police and supply of weapons. Central Government, in consultation with the concerned States has also drawn an Action Plan in this regard which includes:

- (a) ensuring security of police stations, particularly those located in Naxalite affected areas;
- (b) to have a common communication system;
- (c) set up a Control Room in each State;
- (d) Joint Patrolling;
- (e) Launching of Area Domination Programme among the States;
- (f) Strengthening of intelligence network in the affected areas in the concerned States; and
- (g) Ministry of Home Affairs have also arranged for training of police personnel in anti-extremist operations.

Concerned State Governments have been requested to take immediate action to implement the above Action Plan. The action taken by the State Governments is being reviewed at high levels from time to time.

#### Communal Violence

Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether Government propose to take any stringent measures for containing wide spread communal violence in several part of the country;

(b) whether Government have received reports of communal violence resulting in death of people in the last two months from any State/States;

(c) whether the state Governments have been warned to enforce law and order in accordance with the Constitution; and

(d) if so, the States that have attracted such warning from the Centre?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI MOHD. MAQBOOL DAR): (a) to (d) The overall communal situation in the country has considerably improved since 1993. There was major communal violence only in one State i.e. Tamil Nadu during the last two months.

'Public Order' and 'police' being State subjects as per provisions of the Constitution of India, it is primarily for the State Governments to maintain law and order and take necessary steps to check communal violence. However, the Central Government assists the State Governments by sharing intelligence and also by providing Central Para-Military Forces as and when required by the States for maintaining law and order. The Central Government has also issued guidelines to the State Governments for promotion of communal harmony and prevention of communal violence. Further, financial assistance is provided to the State Governments by the Central Government for strengthening their policing infrastructure.

#### **Persons under S.P.G. Security**

(a) the number of persons togetherwith the details of their categories covered presently under the S.P.G. security;

(b) the total month-wise and year-wise expenditure made thereon togetherwith the provision made for these expenditure; and

(c) whether there is any proposal under Government's consideration for its reconsideration keeping in view the day to day increasing expenditure thereon?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI MOHD. MAQBOOL DAR): (a) At present SPG is responsible for providing proximate security to 29 individuals as per the provisions of the SPG Act 1988 as amended. However due to shortage of manpower, SPG has not yet been able to extend its cover to tour of them.

(b) The expenditure incurred by SPG during the last three years is as follow:

The average monthly expenditure during the current year from April 1996 to Jan, 1997 was about Rs. 205 lakhs per month.

(c) The security arrangements for SPG protectees remain under constant review.
