Pasupati Acrylon Ltd. under the Customs Tariff (Amendment) Act, 1995 and Customs Tariff (Identification, Assessment and Collection of Anti-Dumping on Dumped Articles for the Determination of Injury) Rules, 1995, the Designated Authority initiated investigations against alleged dumping of Acrylic Fibres from the Republic of Korea. Central Government has levied provisional duties on 25.4.97. No complaint has been received against imports from Taiwan.
