THE MINISTER OF COMMUNICATIONS (SHRI BENI PRASAD VERMA): (a) Upgradation with expansion of telephone system is based on demand for telephone connections and waiting list. Upgradation is also done for obsolescence of existing technology and life expiry of existing system.
