National Water Policy

†*357. SHRI ANANTRAY DEVSHANKER DAVE: Will the Minister of WATER RESOURCES be pleased to state:

(a) whether a discussion or a meeting was convened to arrive at a consensus in the matter of National Water Policy;

- (b) if so, the suggestions made therein;
- (c) whether Government have formulated any policy on this basis;
- (d) if so, the salient features thereof; and
- (e) by when it is likely to be implemented?

THE MINISTER OF WATER RESOURCES (SHRI ARJUN CHARAN SETHI): (a) to (e) The 4th meeting of the National Water Resources Council under the Chairmanship of Hon'ble Prime Minister was held on 7th July, 2000 for the adoption of revised National Water Policy. During the meeting, the deliberations established a broad consensus among the states on most of the issues contained in the proposed policy. However, there were some areas of differences such as:-

- 1. Formulation of guidelines for water allocation amongst States.
- 2. Amendment of Inter-State Water Disputes Act. 1956
- 3. Establishing appropriate River Basin Organisation with statutory powers.
- 4. Legislation for developing standardized national information system.

The Council decided to constitute a Working Group of Ministers of all the States/Union territories under the Chairmanship of Union Minister of Water Resources to examine the draft of the revised National Water Policy and the draft of the National Policy Guidelines for water allocation amongst states, in order to achieve greater convergence and agreement on issues involving divergent views amongst the members of the Council. The Working Group has been constituted under the chairmanship of the Union Minister of Water Resources on 9th October, 2000 with Ministers from all the States and Lt. Governor/Administrator of Union Territories. Implementation of the revised National Water Policy depends on the outcome of the meeting of the Working Group.
