Out of Course Questions in CBSE Papers

*499. SHRI RAJ NATH SINGH: SHRI RAHASBIHARI BARIK:

- (a) whether it is a fact that a number of questions of various subjects were out of course in the question papers of 10th and 12th class examinations of CBSE, Delhi, held in February-March, 1997;
- (b) if so, the details of the questions, subject-wise and class-wise, which were not prescribed in the NCERT books;
- (c) the- reasons for prescribing questions from out of syllabus for these examinations;
- (d) the persons responsible for this lapse: and

BOMMAl): (a) to (e) Questions are set in Class X and XII examinations conducted by CBSE based on the syllabus drawn up by CBSE for these Cla.sses. According to the CBSE none of the questions is outside the scope of syllabus. A few representations have been received regarding the level of difficulty of questions in the recently conducted examination. These arc being considered in consultation with the experts.
