- (a) whether Government's attention has been drawn to the frequent incidents of suicides by students on the eve of or after examinations and after declaration of results:
- (b) if so, Government's information about the number and details of examination-related suicide-deaths and attempts to suicide by students during last three years in Delhi and in the country:
- (c) the steps, if any, taken to reform the examination system in the country?

MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI S.R. BOMMAI): (a) to (c) The Government have come across occasional of suicide related reports examinations. Details of such suicide deaths are not maintained by this Ministry. These incidents are related to a number of factors including individual personality, home environment, peer pressure and a situation in which career opportunities are very limited in relation to mounting number of aspirants and examinations being a major determinant of career path.

2. Implementation of the examination reforms is a continuous process. The functional steps envisaged in the National Policy on Education 1986 and reiterated in the Programme of Action 1992 incldue climination of excessive elements of chance and subjectivity, de-emphasis of memorisation, continuous comprehensive evaluation, improvement in conduct of examination, introduction of semester system from Secondary stage and use of grades in place of marks.

Procurement of Wheat in Punjab and Harvana

- (c) when was the price revised last time: and
- (d) whether Government propose to increase the price in the near future, if so, by when?

THE MINISTER OF AGRICULTURE AND MINISTER OF FOOD AND MINISTER OF CIVIL SUPPLIES. CONSUMER **AFFAIRS** AND PUBLIC DISTRIBUTION (SHRI CHATURANAN MISHRA): Quantities of wheat procured in Punjab and Haryana during the last two Rabi Marketing Seasons and during the current marketing season are as under:--

(in lakh tonnes)

| Marketing Season | Punjab | Haryana |

| 1995-96 | 72.99 | 31.02 |
| 1996-97 | 56.28 | 20.60 |
| 1997-98 (as on 7.5.97) | 26.17 | 10.31 |

(b) Yes, sir. The Bhartiya Kisan Union had launched an agitation demanding a higher price for the wheat to be sold to the government agencies. The agitation was withdrawn on 28.4.97. There was no direct financial loss incurred by the Government procuring agencies on account of the farmers' agitation except slowing down of the procurement during the period of agitation.
