(c) and (d) Minimum Support Price of wheat is revised every year before the commencement of Rabi Marketing Season. For the current Rabi marketing Season 1997-98, the MSP announced is Rs.415/per quintal. In addition, the farmers will be paid a Central Bounus of Rs.60/- per quintal for selling wheat to public procuring agencies during the period from 17.3.1997 to 10.6.1997.

Reforms in Examination System

- *497. DR. B.B. DUTTA: Will the Minister of HUMAN RESOURCE DE-VELOPMENT be pleased to state:
- (a) whether it is a fact that our examination system causes anxiety and stress in children by emphasizing rote learning instead of understanding;
- (b) if so, the reaction of Government thereto;
- (c) whether Government propose to bring about reforms in the examination system; and
 - (d) if so, the details thereof?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI S.R. BOMMAI): (a) to (d) There are a variety of examination system in vogue at differents stages of education in the country. The stress experienced by examinees is related to a number of factors including individual personality, home environment, peer pressure and a situation in which career opportunities are very limited in relation to mounting number of aspirants and examinations being a major determinant of career path.

2. Implementation of the examination reforms is a continuous process. The functional steps envisaged in the National Policy on Education 1986 and reiterated in the Programme of Action 1992 include elimination of excessive elements of flunee and subjectivity, dc-cmphilisis of memorisation, continuous and comprehensive evaluation, improvement in conduct of examination, introduction of semester system from Secondary stage and use of grades in place of marks.

Implementation of Scheme for Supplying Foodgrains at Half Price

*498. SHRI N. GIRI PRASAD: SHRI GURUDAS DAS GUPTA:

Will the Minister of CIVIL SUPPLIES, CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION be pleased to state:

- (a) whether the scheme for supplying foodgrains at half-price to the people below poverty line has been implemented;
 - (b) if so, the details thereof; and
- (c) if the answer to part (a) be in the negative, the stand of the Government on this scheme and by when it is likely to be implemented?

THE MINISTER OF AGRICULTURE AND MINISTER OF FOOD AND CIVIL SUPPLIES, MINISTER OF CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION (SHRI CHATURA-NAN MISHRA): (a to (c) A statement on the Targeted Public Distribution System (TPDS) has been made in the Rajya Sabha on 24th February, 1997 and detailed guidelines issued in this regard have also been laid on the Table of the House. As per the guidelines, the State Governments/UT Administrations are required to identify the beneficiaries living below the poverty line, based on the provisional estimates arrived at by the Planning Commission adopting the methodology of "Expert Group on estimation of proportion and number of poor" constituted by the Planning Commission under the Chairmanship of Late Prof. Lakdawala. The State Govern-ments/UT Administrations have accordingly been asked to identify the beneficiaries below the poverty line, issue special cards to them and make all necessary arrangements for delivery of foodgrains to the beneficiaries in a satisfactory and transparent manner. As soon as a Statc/UT completes this exercise, it can start deriving the benefits under the scheme. As per information received, Tripura and Haryana have already started
