

**Double Track between Surendranagar
and Rajkot in Gujarat**

3795. SHRIMATI ANANDIBEN JETHABHAI PATEL: Will the Minister of RAILWAYS be pleased to state:

- (a) whether there is any proposal to provide double track railway line between Surendranagar and Rajkot in Gujarat;
- (b) if so, the details thereof; and
- (c) the time by which it is proposed to be completed?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) No, Sir.

(b) Under the extant rules, the expression "Running staff refers to staff whose performance of duties is directly connected with the charge of moving trains. As the Travelling Ticket Examiners are not directly connected with the charge of moving trains, they are not classified as Running staff.
