Governments. However in order to supplement the efforts of the States, the Central Silk Board (CSB) has set-up a country-wide network of units to extend necessary R&D, extension, training & infrastructural support without confining it to any specific State. The number of such units in the States of Karnataka, Madhya Pradesh and North-East is 38, 19 and 47 respectively. Based on their agroclimatic and technical factors relevant to sericulture, the concerned States can avail of these support systems of the CSB which include various incentive programmes for development sericulture such as supply of mulberry cuttings, augmentation of muga food plants, production development and marketing for eri etc. In addition, CSB from time to time takes up sericulture development projects (both for mulberry and non-mulberry) in collaboration with State(s). The major projects which have specifically benefited the expansion of sericulture both in Madhya Pradesh and the North-East during the last five years are the National Sericulture Project (NSP), Inter-State Tasar Project in Madhya Pradesh, Project for the Development of Nature Grown Tasar Cocoons in Madhya Pradesh and the Action Plan for the North-Eastern States.

PCO booths in urban and rural areas of Rihar

- (c) and (d) Sir, preference in allotment is given to SC/ST applicants by the STD PCO allotment committee. However, no separate data is maintained in this regard.

- (b) No, Sir. The telephone exchange is working satisfactorily. Trunk calls can be booked at Kupwara and Sopore.
- (c) and (d) No, Sir. The public demand justify only 256 port electronic exchange, which is planned to be commissioned during 1997-98.
