## Foreign direct investment in Maharashtra

## 3870. PROF. RAM KAPSE: SHRI RAJ NATH SINGH:

Will the Minister of INDUSTRY be pleased to state:

- (a) whether Maharashtra has received the maximum amount of foreign direct investment in the last five years;
- (b) if so, the amount of investment along with details of the proposals cleared; and
- (c) by when the pending proposals are likely to be cleared?

THE MINISTER OF INDUSTRY (SHRI MURASOLI MARAN): (a) and (b) No, Sir. In the post policy period, *i.e.*, from August 1991 to February 1997 foreign direct investment to the tune of Rs. 13575.22 crore involving 1382 foreign direct investment proposals (including technical) have been approved and it counts for 12.57% of the total foreign direct investment.

(c) Foreign investment proposals received in the Secretariat for Industrial Assistance (SIA) are placed before the Foreign Investment Promotion Board within 15 days of receipt. The decision of the Government on foreign investment proposals are conveyed by the SIA normally within 6 weeks.

- (a) the year-wise approvals of foreign investment in India during the last five years;
- (b) the percentage of investments that materialised, year-wise;

  - (d) if so, the reasons therefor?

THE MINISTER OF INDUSTRY (SHRI MURASOLI MARAN): (a) and (b) The yearwise break up of foreign investment in India

during the last five years is as under:-
