## Accident of Nagarjun-Inter City Express 2236. SHRI SUSHILKUMAR SAM-

230. SHRI SUSHILKUMAR SAF BHAJIRAO SHINDE: SHRI RAJUBHAI A.

VERMA: Will the Minister of RAILWAYS be pleased to state:

(a) whether over thirteen bus passengers were killed and several others injured as a bus rammed into the Nagarjun-Inter City Express at an unmanned rail level crossing near Guntur; and

(b) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) and (b) Yes, Sir. On 27.1.97, 7006 Inter-City Express dashed against a bus at unmanned level crossing between Bandarupaiii and Nallapadu stations of Vijayawada Division of South Central Railway. In this accident, 16 bus passengers were killed and 7 injured. The accident took place due to failure on the part of the bus driver to take precaution, as laid down under Section 131 of the Motor Vehicles Act, before negotiating the level crossing.

## LRTS in Hyderabad

Under the revised Allocation of Business Rules. 1986, proposals for such rail based urbnu rmnsport Projects are now to he processed by the Ministry of Urban Affairs and Employment and the State Government concerned. Railways in not involved in the LRTS project in Hs derabad.

(c) by when the work on the project is 'y to commence?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) to (c) There is a proposal for opening of a halt station at Preet Vihar between Tilak Bridge and Anand Vihar stations. The proposal has been examined several times in the past but has neither been found operationally feasible nor financially justified. Besides, the area is well connected by road transport facilities.
