THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI M.P. VEERENDRA KUMAR): (a) State Bank of India (SBI) have reported that as at the end of March 1997, the bank had fully computerised 670 branches. The current plan is to fully computerise another 700 branches by March, 1998.

- (b) According to SBI, per branch cost of computerisation works out on an average to Rs. 20 lakhs inclusive of UPS, airconditioning, etc.
- (c) As reported by SBI, the data relatining to business per employee prior to computerisation and the estimated business per employee post computerisation are as under:

विदेशी मुद्रा भंडार का उपयोग किया जाना

4303. श्री सुन्दर सिंह भंडारी: क्या वित्त मंत्री यह बताने की कपा करेंगे किः

- (क) इस समय भारत का विदेशी मुद्र भंडार कितना है और इसमें भारतीय रिजर्व बैंक द्वारा भारतीय रुपए के बदले खरीदी जाने वाली राशि कितनी है;
- (ख) विदेशी मुद्रा भंडार का किन-किन योजनाओं के संबंध में उपयोग करने पर विचार किय्यू जा रहा है; और

(ग) क्या यह सच है कि भारतीय रिजर्व बैंक केवल अनुमोदित विदेशी प्रतिभृतियों में ही विदेशी मुद्रा भंडार का उपयोग कर सकता है?

वित्त मंत्रालय में राज्य मंत्री (श्री एम॰पी॰ वीरिन्द्र कुमार): (क) मार्च, 1997 के अंत में भारत का विदेशी मुद्रा भंडार (सोने तथा विशेष आहरण अधिकारों को छोड़कर) 22367 मिलयन अमरीकी डालर था जो 1996-97 के दौरान 5323 मिलियन अमरीकी डालर की वृद्धि दर्शाता है। यह वृद्धि काफी हद तक भारतीय रिजर्व बैंक द्वार विदेशी मुद्रा बाजार से किए गए विदेशी मुद्रा के क्रय का परिणाम थी। वित्तीय वर्ष 1996-97 के दौरान, विदेशी मुद्रा बाजार के हाजिर वायदा और विनिमय खंडों में अमरीकी डालर की निवल खरीद 7800 मिलियन अमरीकी डालर थी।

(ख) और (ग) विदेशी मुद्रा प्रारक्षित भंडारों का प्रबन्ध समग्र वृहत आर्थिक प्रबन्धन का एक अभिन्न भाग है। विदेशी मुद्रा प्रारक्षित भंडारों के नियोजन के पोर्टफोलियों समूह का निर्णय करते समय भारतीय रिजर्व बैंक निवेश की गई निधियों को मौद्रिकता, अर्जन और सुरक्षा को ध्यान में रखता है।

जैसािक भारतीय रिजर्व बैंक अधिनयम, 1934 की धारा 33(6) के तहत निर्धारित किया गया है, भारतीय रिजर्व बैंक विदेशी मुद्रा भंडारों को विदेशी प्रतिभूतियों सहित विभिन्न लिखितों में निवेश कर सकता है।

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI M.P. VEERENDRA KUMAR): (a) Punjab & Sind Bank has reported that subject to administrative and business requirements of the bank, managers/senior managers are rotated keeping in view, inter aliatheir suitability at a particular branch/ office, nature and potential of business and capacity of the officer concerned as assessed to handle such business. The bank has further reported that keeping in view the above, managers/senior managers are normally rotated from one branch to the other within a period of three to five years.

- (b) and (c) The bank has reported that three officers have been transferred from Zonal Office, Dehradun to other zones for reasons such as recommendations of Vigilance Department, completion of tenure and performance not being upto the mark.
- (d) and (e) Request from one of the officers from Dehradun Zone was received and examined by the bank but was declined due to administrative exigencies.
