THE MINISTER OF STATE IN THE MINISTRY OF **POWER** (DR. VENUGOPALACHARI): (a) and (b) West Bengal Power Development Corporation Ltd. (WBPDCL), a Government of West Bengal Undertaking, is executing the Bakreswar Thermal Power Project (3x210 MW) with financial assistance from the Overseas Economic Cooperation Fund (DECF), Japan. As per the loan agreements, the recommendations for award of contracts for various packages of the project costing more than 500 million Japanese Yen are inter-alia required to be finalised after obtaining the concurrence of the DECF. The recommendations of WBPDCL, with respect to the Water intake and plant water system package, are currently under examination in the Government of India before they are fowarded to DECF.

Surplus Land under Ceiling Land Laws

- (a) whether it is a fact that the land declared surplus under Land Ceiling Laws as on the 30th November, 1995 has not been distributed as yet; if so, the details in this regard;
- (b) the area of surplus land distributed during 1996-97 till date, State-wise; and
- (c) what steps are being taken to speed up implementation of Land Ceiling Laws?

THE MINISTER OF RURAL AREAS AND EMPLOYMENT (SHRI K. YERRANNAIDU): (a) No, Sir. On 31st December, 1995 net area of land available for distribution was 8.42 lakh acres. During the period in question, 0.70 lakh acres of land was distributed.

- (b) A Statement is laid on the Table of the House. (See below).
- (c) The distribution of ceiling surplus lands by the States is being monitored. Conferences of Revenue Secretaries as well as Revenue Ministers are being convened from time to time in which the implementation of land ceiling laws also is reviewed and the measures to speed up the process discussed.

- (iii) Further augmentation of Salaya-Viramgam Section and Viramgam-Koyali Section of existing Salaya-Mathura Crude Oil Pipeline to 20 MMTPA is under implementation.
