

SAARC Decade (1991-2000 AD) for the girl child focussing on the survival, protection and development of the girl child has been formulated. A special set of interventions for adolescent girls has been institutionalised through the ICDS structure.

(d) Law, order and criminal matters are a State subject under the Constitution and therefore, the direct responsibility for dealing with enforcement of the acts are, that, of the State Governments and the mechanisms under them. The registration, investigation, detection and prevention of crimes against women is primarily the responsibility of the State Governments/UT Administrations. However, the Government of India has initiated a number of measures to check such crimes. Apart from legislative changes in the relevant Acts, instructions/guidelines have been issued from time to time to the State Governments/Union Territory Administrations to effectively enforce legislation relating to crimes against women and the girl child.
