- (a) whether it is a fact that knowledge of Hindi has been made compulsory for the post of teachers of all subjects in.Central Schools from the year 1986;
- (b) whether Government are aware that qualified candidates from Tamil Nadu have not been able to apply for the post of teachers in Central Schools for the-last ten years because of this revised condition; and
- (c) whether Government would consider waiving the kndwledge of Hindi as requisite qualification atleast for the candidates hailing from non-Hindi speaking States like Tamil Nadu?

THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF KURIAN RESOURCE DEVELOPMENT (SHRI MUHr RAM SAIRtA)'. (a) tO (c) Competence to teach through both Hindi & English Media, is one of the essential qualifications for appointment to the-post of Primary Teachers, Trained Graduate Teachers and Post Graduate Teachers, except Post Graduate Teacher (Commerce) and (English).

A large number of applications are received in response to advertisement from all over the country including Tamil Nadu for all posts.

Discovery of Buddhist Stupa in Andhra Pradesh

54. DR. ALLADI P. RAJKUMAR: DR. Y. LAKSHMI PRASAD:

Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to" state:

- (a) whether a large Buddist stupa of second century has been recently discovered in Khammam district of Andhra Pradesh',
 - (b) if so, the details'thereof; and

(c) whether further excavations are being carried out at the site to determine if there existed a large dwelling complex near the stupa?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI S.R. BOMMAI): (a) to (c)Yes, Sir. The excavations undertaken by Department of Archaeology, Government of Andhra Pradesh from 1986-87 at village Nelakondapalli, District Khammam, have brought to light a Buddhist stupa, monastic, cells, congregation halls and chaitya, nine Buddha idols, a model of a stupa containing Brahmi legend, and coins of Satavahana, Ikshvaku, Chantamula and Vishnukundin rulers. A panchdhatu Budha image has also been unearthed.

Recruitment/Promotion to Group 'A' posts including that of Education officers are done in accordance with the Recruitment rules.
