including construction of mini stadia, etc. in the rural areas.

- (ii) Grants to Rural Schools for purchase of non-consumable sports equipment and development of playground.
- (iii) Grants for Rural Sports Tournaments exclusively for rural areas.

The Central Government, however,- has no proposal for constructing mini stadia in the villages all over the country.

National Policy for Empowerment of Women

Elimination of Violence Against Women

- 65. SHRI IQBAL SINGH: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:
- (a) whether Government have formulated any National Policy for eliminating violence against women, particularly sexual abuse, and creating a mechanism for rehabilitating such victims;
- (b) whether Government propose to remove the discrimination, against girl child in the family and outside and the projection of a positive image of the girl child in the country;
- (c) if the replies to parts (a) and (b) be in the positive, the details thereof; and
- (d) the steps being taken by Government for strict enforcement of laws against pre-natal sex selection and foeticide, female infanticide, child marriage, child abuse and child prostitution?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI S.R. BOMMAI) (a) Yes, Sir. The Government of India have drafted a Natioal Policy for the empowerment of Women, which inter-alia provides for elimination of all forms of violence against women and economic empowerment of women.

(b) and (c) Various programmes of action and advocacy are being implemented by the Government of India in the country for the welfare and development of women- and the girl child. With a view to regulate and prevent the misuse of modern pre-natal diagnostic techniques, particularly misuse for detection and selective abortion of female foetuses, Parliament enacted The Pre-natal Diagnostic Tecniques (Regulation and Prevention of Misuse) Act, 1994.* The Act came into force w.e.f. 1.1.1996. Attempts are also being made to project positive images of the girl child so as to bring about changes in societal attitudes towards them The Government has also initiated a media campaign to generate awareness on various Issues relating to the girl child. The National Plan of Action for the

SAARC Decade (1991-2000 AD) for the girl child focusing on the survival, protection and development of the girl child has beep formulated. A special set of interventions for adolescent girls has been institutionalised through the ICDS structure.

(d) Law, order: and criminal matteris a State subject under the Constitution and therefore, -the direct; responsibility for dealing with enforcement of the acts are, that, pf the State Governments and the mechanisms under them. The registration, investigation, detection and prevention of crimes against women is primarily the responsibility the of GovenuneoR/UT Administrations. However, the Government, of India has initiated a number of measures to check such crimes. Apart from legislative changes in the relevant Acts, instructions/guidelines have been issued timejo from time to State the Governments/Union **Territory** Administrations to effectively enforce legislation relating to crimes against women and the girl child.
