- (a) the recruitment procedure of Education Officers, both direct and promotees, in Kendriya Vidyalaya Sangathan;
- (b) whether it is distinguishably different from that of other posts of Group 'A'; and
- (c) if so, the details and, justification thereof?

THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI' MUHI RAM SAJKIA): (a) to (c) In accordance with the recruitment rules of Kendriya Vidyalaya Sanghathan, 50% pasts of Education Officers are filled by direct recruitment and 50% by promotion from amongst Principals. Recruitment/Promotion to Group 'A' posts including that of Education officers are done in accordance with the Recruitment rules.

### **Universalisation of Elementary Education**

- 57. SHRI IQBAL SINGH: Will the Minister -of HUMAN DEVELOPMENT be pleased to state:
  - (a) whether Government's attention has been drawn to the news item published in "The Tribune" dated 3rd February, 1997, under the caption "630M Kids still out of school" wherein it has been stated that Government's goal to achieve universalisation of elementary education by the turn of the century appears a distant dream:
    - (b) if so, the details thereof; and
  - (c) whether Government have since received the report the Committee set-up in this regard, if so, the details thereof alongwith Government's decision regarding its recommendations?

THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): (a) Yes, Sir.

(b) and (c)The news item refers to the report of the Committee of State Education Ministers on implications of the proposal to make elementary education a Fundamental Right, "which inter alia mentions that the number of out of school children in the age group of 6—14 years is estimated to be 6.3 crore i.e. (63 million). The report is under examination in this Ministry. A copy of the report is available in the Parliamentary Library.

- (c) if so, the details thereof; and
- (d) the modus operandi of promoting teachers in KVS?

THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): (a) to (c) The Board of Governors of Kendriya Vidyalaya Sangathan ih its'62nd Meeting held on 27th January 1997 inter-alia enhanced the promotion quota from 33 1/3% to 50% for effecting promotion from Primary Teacher to Trained Graduate Teacher and Trained Graduate Teacher to Post Graduate Teacher.

(d) Promotion are effected in accordance with the recruitment rules prescribed for the posts and as per the guidelines laid down by Department of Personnel & Training from time to time.

### **School Dropouts**

- 60. SHRI W,ANGOU SINGH: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:
- (a) the total number of school dropouts in the country, State-wise and Unipnterritory-wise;

- (b) whether the dropouts are mainly in the primary stage Tor the High School stage; and
- (c) whether Government have "any plan for liquidating the school dropouts?

THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MUHI RAM JSAIKIA): (a) and (b) According to available information, the dropout rates at primary, upper primary and high school stages in 1993-94 were 36.22%, 52.80% and 70.90% respectively. State-wise and Union-territory-wise details are given in the statement (See below)

(c) Government have taken a number of measures to reduce the dropout rates. These include Micro-planning and Community mobilisation; greater involvement of Panchayati Raj Institution; improvement of school infrastructure through Operation Blackboard Scheme; incentives for girls and SC/ST students; establishing and strenghening of institutions of teacher education; introduction of Minimum Levels of learning and implementation of Mid-day Meals Programme.
