

**Problems faced by Agarbatti Industries**

2930. SHRI RAJUBHAI A. PARMAR:  
SHRI SHIVCHARAN SINGH:

Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

(a) whether Government have received any representations from the Agarbatti Industry in Karnataka and other States, about the scarcity and difficulties, faced by them in procuring the wood required for manufacture of agarbattis arising from the recent Supreme Court judgement banning the collection of wood from the forest;

(b) if so, the details thereof; and

(c) the steps taken to help the industry out of the crisis?

THE MINISTER OF ENVIRONMENT AND FORESTS (PROF. SAIFUDDIN SOZ): (a) Yes, Sir.

(b) Representations were received from Government of Karnataka & Tripura. Various affected parties have also filed interlocutory applications before the Hon'ble Supreme Court of India.

(c) Supreme Court vide interim order dated 4.3.1997 have clarified that interim order dated 12.12.1996 would not apply to bambo, which is one of the basic raw materials for agarbatti sticks.

**Supreme Court judgement on Prawn Culture**

SAIFUDDIN SOZ): (a) and (b) In compliance with the directions of the Hon'ble Supreme Court on December 11, 1996, Government have constituted an Aquaculture Authority under Section 3(3) of the Environment (Protection) Act, 1986. This Authority will deal with all issues relating to shrimp culture industry in the coastal areas of the country.
