Share of Dhabas, Tea Stalls in pollution of Delhi

*394. SHRI SANJAY NIRUPAM: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

- (a) the share of dhabas, tea stalls in the total level of environmental pollution in the capital;
- (b) whether it is a fact that such shop owners in the crowded market places like Karol Bagh and adjoining areas start lighting their ovens installed outside the shops, from very early hours of the day which emit smoke and add to the already polluted environment of the capital:
- (c) if so, the action taken or proposed to be taken by Government against them. if not the reasons therefor; and
- whether Government identify such polluted market segments in the capital and take action against the polluting establishments?

OF THE MINISTER **FORESTS** AND **ENVIRONMENT** (PROF. SAIFUDDIN SOZ) (a) to (d) No study has been carried out to determine the share of dhabas and tea stalls to the total level of environmental pollution in the capital. However, it is known that such shop owners in crowded market places light oven outside their shops. The contribution of pollution from such shops to the total air pollution in Delhi is very small, as such no action has been initiated against these shop owners.

Introduction of Ahmedabad Raidhani will be done after Delhi-Ahmedabad route is made fit to run Rajdhani Express. Secunderabad be Rajdhani will introduced of the Rajdhani rake. availability Bangalore-Nizamuddin Swarna-jayanti Express (weekly) via Hubli is proposed to be introduced during August, 1997.

(c) and (d) The additional services proposed in Assam during the first half of 1997 include extension of 4055/4056 Delhi-Dimapur Brahmputra Mail to Tinsukia/Dibrugarh Town and passenger shuttle services on Lumding-Tinsukia/ Dibrugarh Town section on completion of the guage conversion works.
