Cotton Bales for export fails to find customers in the International Market

550. SHRI K.M. SAIFULLA: Will the Minister of TEXTILES be pleased to state:

(a) whether it is a fact that the quota of several lakh bales of cotton recently released for export by the Ministry is not findings customers in the international market; and

(b) if so, the reasons therefor and the steps Government propose to take in this regard?

THE MINISTER OF TEXTILES (SHRI R.L. JALAPPA): (a) No, Sir.

Profit and Loss Incurred by the Mills of National Textile Corporation

551. SHRIMATI JAYAPRADA NAHATA: Will the Minister of TEXTILES be pleased to state:

(a) the number of NTC mills which earned profit in 1995-96 and 1996-97;

(b) the number of NTC mills incurred loss in 1995-96 and 1996-97; and

(c) the measures proposed to revive sick mills?

THE MINISTER OF TEXTILES (SHRI R.L. JALAPPA): (a) and (b) Only one mill out of 120 mills has made a provisional net profit during 1996-97 (April-September, 96). All the remaining 199 mills have made net losses in 1996-97. During the year 1995-96, all the 120 NTC mills had incurred net losses.

(c) Due to continuous losses and total net worth erosion, 8 out of 9 subsidiary corporations of NTC have been referred to the BIFR which, has declared them to be sick industrial companies. Government have approved a Revised Turn Around Plan for rehabilitation of NTC, involving modernisation of 79 mills at an outlay of Rs. 2005.72 crores, restructuring of 36 unviable mills into 18 viable units etc. The plan has been placed before the BIFR for its approval before implementation. The funds for modernisation will be met out of the proceeds of sale of surplus lands and assets of NTC. Once the BIFR approves the plan and funds are raised from sale of surplus lands and assets, the rehabilitation plan will be implemented leading to revival of NTC mills.
