LPG Distributors in Nalanda

596. SHRI RAJ NATH SINGH: Will the PRIME MINISTER be pleased to state:

(a) what is the number of LPG distributors in Nalanda District of Bihar;

(b) whether Government have assessed/propose to assess the requirements of Nalanda and its adjoining villages for setting up of LPG dealership at Nalanda;

(c) if so, the details thereof; and

(d) if not, the reasons therefor and by when Government propose to assess the same?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM & NATURAL GAS (SHRI T.R. BAALU): (a) At present, there are four LPG distributorships in Nalanda Distt, of Bihar.

(b) to (d) Instructions have been issued to the Oil Industry to carry out a market survey for opening of LPG distributorship at Nalanda, after taking into consideration the potential of the adjoining villages within IS KM radius. This location will be included in the next LPG marketing plan provided it has adequate potential to sustain a commercially viable LPG distributorship.

Waiting List for LPG Connections of HPC

597. SHRI AKHILESH DAS: Will the PRIME MINISTER be pleased to state:

(a) what is the total number of applications pending with the Hindustan Petroleum Corporation for issue of LPG connections, as on date: (b) what is the rratnber of gas connections likely to be provided during 1997; and

(c) by when the remaining applications arc likely to be cleared by the Corporation?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI T.R. BAALU): (a) As on 31.12.1996, Hindustan Petroleum Corporation Ltd. has a waiting list of 37,28,561 persons for release of LPG connections all over the country.

(b) and (c) LPG connections are released in a phased manner throughout the country depending upon the LPG availability, waiting list, slack available with the distributors and their viability. It may, therefore, not be possible to indicate a definite time frame for release of connectiong to the waitlisted persons.

Drilling Rigs of ONGC

(a) whether it is a fact that the ONGC had only 40 drilling rigs in 1982; if so, the number of wells dug per year by the ONGC using these rigs per year;

(c) whether the ONGC was running at a profit in 1985; and

(d) what is its profit and loss position after 1985?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI T.R. BAALU): (a) and (b) As on 1.4.1982, ONGC had 44 drilling rigs (40 owned and 4 charter-hired).
