- (a) the number of Delhi Public Schools (DPS) at present in Delhi/New Delhi and NOIDA;
- (b) whether it is a fact that these schools are functioning under private organisations and they are charging high amount of tuition fee/donation from the public and earning huge money for the last three years;
- (c) whether it is also a fact that the Principals of these schools are retired Government servants/ex-servicemen etc.;
- (d) if the answer to parts (a) and (b) is in the affirmative, the action taken against the Principals and whether Government would ensure that all Principals are appointed as per Government rules; and
 - (e) if so, the details thereof?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI S.R. BOMMAI): (a) Four, Sir.

- (b) These schools are being run by a registered society. According to the information made available by the Government of the National Capital Territory of Delhi, the Government of Uttar Pradesh and Central Board of Secondary Education, the levy of tuition fee and other charges in these schools is governed by rules and regulations laid down in this respect.
- (c) According to the available information, there is one Principal belonging to the category of Ex-Serviceman working in the school located in Mathura Road, Delhi.
- (d) and (e) In view of the reply given at (a) and (b) above, the question of taking action against the Principals does not arise. As regards the appointment of

Principals, as per Government rules, the respective State Governments have the authority to take the required action under their own rules.

Cadre Review in the Railways

- (a) whether Government are aware of the heavy discontentment brewing in the various cadres of Railway seravices over the delay in the cadre review as well as the practice of granting extension to the rank of Joint Secretary and above;

THE MINISTER OF RAILWAYS (SHRI RAMVILAS PASWAN):(a) to (c) Implementation of last Cadre Review of Organised Group 'A' Railways Scrvices stretched upto 1990. The next Cadre review was taken up in 1993. As per procedure, the proposals were projected for consideration by concerned authorities and sufficient progress was made. With the submission of the Report by V Central Pay Commission, the projections have to be reformulated keeping in view recommendations of the Commission.

As regards grant of extension of service to the rank of Joint Secretary and above, extension to two officers has been granted during the year 1996-97, keeping in view the requirement of Ministry of Railways and exigencies of their services.

The issues were raised by Federation of Railway Officers' Associations in their meeting with the Railway Board held on 20-12-96 when the position was explained.
