Polluting Factories in Salem District of Tamil Nadu"

781. SHRLR. MARGABANDU: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

- (a) the names of the factories which allow untreated effluent water into the open lands and rivers in Mettur Dam area in Salem District and Tiruppur town in Coimbatore of Tamil Nadu;
- (b) whether Government are aware that the land has become unfit for cultivation and causing health hazards; and
- (c) if so, the details of the action taken against such factories and tanneries?

THE MINISTER OF **ENVIRONMENT** AND **FORESTS** (PROF. SAIFUDDIN SOZ): (a) The names of the factories which allow untreated effluent into open drain and river Cauvery in Mettur Dam area in Salem District are:-

- (i) MS. Murthy Thread Mills.
- (ii) MS. Anna Transport Corporation Ltd., Depot and

(iii) MS. Tansi Structural & Structural & Galvanishing Works.

(b) and (e) So far, no specific complaints have been received by the Tamil Nadu Pollution Control Board to indicate that lands have become unfit for cultivation and causing health hazards. The Board has issued show cause notice to the above three units. The 259 tanneries in the State, who are yet to install effluent treatment plants are under closure as per the orders of the Hon'ble Supreme Court and the High Court.
