**ALLOCATION OF TIME FOR
DISPOSAL OF GOVERNMENT AND
OTHER BUSINESS**

THE DEPUTY CHAIRMAN: I have to inform Members that the Business Advisory Committee at its meeting held on Thursday, the 5th December, 1996 allotted time for Government Legislative Business as follows:

- (1) Consideration and return of the Income Tax (Amendment) Bill, 1996, as passed by Lok Sabha. It may be disposed of without discussion because there is nothing to be discussed in this matter. ... (Interruptions) ... It is in relation to Andhra cyclone. We are giving some consideration to that That is why I am saying this. There cannot be two opinions on this. We have to support the cyclone affected people of Andhra.
- (2) Consideration and passing of the Companies (Amendment) Bill, 1996.— 2 hours.
- (3) Consideration and passing of the Delhi Development (Amendment) Bill, 1996, after it has been passed by Lok Sabha— 2 hours.
- (4) Consideration and passing of the Constitution (Eightieth Amendment) Bill, 1996, after it has been passed by Lok Sabha.—4 hours.

SHRI GURUDAS DAS GUPTA (West Bengal): Madam, I have to make a point in regard to this Business. ... (Interruptions) ... Madam, the Government is not informing the House about its intentions on the Insurance Bill. Everything is being said outside. Madam, you must have seen today's newspapers; there is even a news item that the Government is insistent that this Bill should be passed in this Session. But we are not being informed. I would like to request that the Government , should not take the House by surprise. If they

want to introduce it, they should make their intentions clear. ... (Interruptions)
