THE MINISTER OF CIVIL AVIATION (SHRI CM. IBRAHIM): Madam, I have also made the statement in the Lok Sabha on the air crash.

THE DEPUTY CHAIRMAN: Let us get this laid first.

SHRI SATISH AGARWAL: Similarly, Mr. Ibrahim can lay the statement and clarification can be taken up later on.

THE DEPUTY CHAIRMAN? MR. Agarwal, I can run the House. You don't keep on interrupting. It is very irritating. Mr. Gujral, please lay your statement.

THE MINISTER OF EXTERNAL AFFAIRS (SHRI I. K. GUJRAL): Madam, I lay on the Table of the House a statement regarding the situation in Afghanistan. I also assure my friends that since on 3rd December there is going to be a debate here, I can reply to those questions at that time also.

We have deprived the Members from Orissa and all those who are interested in the other subjects. So, next time we should be a little careful about it.....(Interrup tions)....

SHRI JOHN F. FERNANDES: It should be listed for Friday, Madam.

SHRI V. NARAYANASAMY: We can seek clarifications on the drought situation in Orissa and the mid-air collision near Delhi tomorrow at 12 O'clock-.... (Interruptions)....

THE DEPUTY CHAIRMAN: I will look into the business for tomorrow. About having them at 12 O'clock, I don't know. If everybody decides that they

don't want Special Mentions and Zero Hour submissions, then, fine. Otherwise, no. We can't have our cake and eat it too!

DR. BIPLAB DASGUPTA (West Bengal): We leave it to you, Madam,

THE DEPUTY CHAIRMAN: We will discuss it in the morning with the Chairman. If he wants to adjust some time, he will see that the Ministers are available. Okay? Thank you for all the cooperation.
