(a) whether Government's attention has been drawn towards a news-item published in the Hindustan Times dated 3rd October, 1996, with a heading "Illegal copper trade has cost crores" mentioning another scam in the offing and cheating of the Government exchequer of hundred crores of rupees each year; and

(b) if so, the details of the case and the action Government propose to take against the defaulters and to prevent the cheating firms from doing their business further?

#### De-licencing of industries

THE MINISTER OF INDUSTRY (SHRI MURASOLI MARAN): (a) and (b) The Government have reviewed the list of industries under compulsory licensing and decided to de-licence "Entertainment Electronic-Industries" and the review is a continuous process.

#### Sick industrial units

986. SHRI K. RAHMAN KHAN: Will the Minister of INDUSTRY be pleased to state:

(a) whether it is a fact that a number of industrial units are lying sick in the country;

(b) if so, the total number of such sick units. State-wise;

(c) whether Government have any plan to rejuvenate these sick industrial units;

(d) if so, the details thereof; and

(e) if not, the reasons therefor?

THE MINISTER OF INDUSTRY (SHRI MURASOLI MARAN): (a) and (b) Data on sick industrial units assisted by Banks in the country is compiled by the Reserve Bank of India. According to the latest RBI data available, the statewide distribution of sick industrial units as at the end of March 95 is at Statement I. (See below)

(c) to (e) The Government has taken a number of steps for revival of sick industrial units. Some of the important steps are at Statement-II.
