

**Women Workers in Beedi Industry**

1057. DR. (SHRIMATI) BHARTI RAY: Will the Minister of LABOUR be pleased to state:

(a) whether it is a fact that 65.9 per cent of workers in Beedi industry are women;

(b) whether any information on the ratio of organised workers to unorganized worker has been attempted;

(c) whether special measures have been taken to protect their rights and conditions of work;

(d) whether steps have been taken to improve the housing conditions of those female beedi workers who take work at home; and

(e) if so the details thereof?

THE MINISTER OF LABOUR (SHRI M. ARUNACHALAM): (a) and (b) As per the Report on Working and Living Conditions of Workers in Beedi Industry in India prepared by Labour Bureau (1995), it is estimated that 65.9% of workers in the beedi industry are women. Also, as per the same Report, the unorganised labour constitutes more than 90% of the total work force in the country, in general.

(c) Beedi and Cigar Workers (conditions of Employment) Act, 1966, has been enacted to safeguard the interests of beedi workers and to regulate the Conditions of their work.

(d) and (e) Housing Scheme for Economically Weaker Section of Workers engaged in Beedi Industry and Build Your Own House Scheme for Beedi Workers are being implemented by the Government under the Beedi Workers Welfare Fund Act, 1976. Benefits under these schemes are not gender specific.

(e) the reasons for import despite availability of adequate quantity of coal in the country?
