(c) The cyclical fluctuations in production, exports and prices are part of the dynamics of the development process. There are indications that in the second half of the current financial year industrial and export growths are likely to stabilise and improve.

Long pending demand of linking Bombay, M.P., Bihar and Orissa by flights

- 1117. SHRI SANJAY NIRUPAM: Will the Minister of CIVIL AVIATION be pleased to state:
- (a) whether Government are aware of a long pending demand of a daily flight on Bombay-Jabalpur-Patna-Raipur-Bhubaneshwar route linking thereby Bombay with Madhya Pradesh, Bihar and Orissa;
- (b) if so, whether any feasibility of survey was undertaken or being undertaken to meet the growing demand from the passengers; and
- (c) if so, by when such flight is likely to be introduced and if not, the limitation thereon?

- (b) and (c) Indian Airlines is already operating thrice a week A 320 service on sector Mumbai-Patna-Ranchi-Calcutta and return. They have no plans operate on Mumbai-Jabalpur-Patna-Raipur-Bhubaneshwar route, at present, to operational/commerical constraints. However, Private Operators are being encouraged to start services to these stations.

The cases of foreign investers is determined by the procedures of the Foreign Investment Promotion Board.
- (b) and (c) Two proposals of NRIs for setting up hospitals at Bhubneshwar have been approved. These proposals are from M/s. Kalinga Hospital Pvt. Ltd., Puri at the cost of Rs. 650.00 lakhs and M/s. Orissa Heart Institute at the cost of Rs. 300.00 lakhs, respectively.
