1161. SHRI BHAGABAN MAJHI: Will the Minister of CIVIL AVIATION be pleased to state:

- (a) whether Government have a proposal to upgrade some airports in Ninth Plan:
- (b) if so, the airports identified so far upgradation:

- (c) whether any airports has since been upgraded in Eighth Plan; and;

THE MINISTER OF CIVIL AVIATION (SHRI C.M. IBRAHIM): (a) to (c) Upgradation, expansion and modernisation of airports is a continuing process and is taken up in a phased manner depending upon projected requirements and availability resources.

- (d) The Ninth Five Year Plan of the Department of Civil Aviation is yet to be approved. It is, therefore, difficult to indicate the schemes at this stage.
- (c) and (f) During the Eighth Five Year Plan period, Airports Authority of India has upgraded Ahmedabad. Agartala, Agra, Aurangabad, Bhubaneshwar, Bhopal, Bagdogra, Calicut, Bangalore, Coimbatore. Dibrugarh, Dimapur, Guwahati, Goa, Hyderabad, Indore, Imphal, Jaipur, Jodhpur, Kargil, Lilabri, Leh, Lucknow, Ludhiana. Nagpur, Patna, Raipur, Tezpur, Tirupati,. Vadodara. Silchar. Mumbai, Delhi, Calcutta, Madras and Thiruvanathapuram airports.

Developmental works undertaken included extension of runway, taxiway, apron, construction of new terminal buildings etc. Installation/modernisation of navigational/communication aids is

also done keeping in view operational safety requirements.

KHALAP): (a) to (c) The National Voter Awareness Compaign was launched by the Election Commission of India to improve the general awareness amongst the masses of the right of franchise, etc. The women were identified as one of the priority target groups of audience for being addressed specifically and in an organized manner. A Conference on the Women's Voter Awareness Compaign was held at Nirvachan Sadan on 3.1.1995. assessment of responses has, however, been made by the Commission in this regard.

Inadequate Accommodation for Tourists in India

OF THE MINISTER PARLIAMENTARY AFFAIRS AND THE MINISTER OF TOURISM (SHRI SRIKANTA JENA): (a) and (b) Yes, Sir. Construction of hotels is primarily a private sector activity. To encourage the construction of hotels, the Government of India provides various fiscal benefits/ incentives, and a special incentive by way of interest subsidy is given to hotel projects approved in the one, two & three star category, to augment construction of economy hotels to meet the needs of the accommodation segment of the infrastructure.

At present there are 683 approved projects in the pipeline totalling 35,452 rooms of which 587 projects with 26674 rooms are of the one, two and three state category.
