## Import of Naphtha for power generation

1413. PROF. NAUNIHAL SINGH: Will the PRIME MINISTER be pleased to state:

- (a) whether it is a fact that import of Naphtha and FO/LSHS for power generation has been allowed;
  - (b) if so, the quantity thereof;
- (c) whether it is a fact that the Ministry of Petroleum and Natural Gas has agreed to meet all the demand of liquid fuel for power plants;
  - (d) if so, to what extent;
- (c) whether it is also a fact that the Ministry of Petroleum and Natural Gas has allocated Naphtha for the environmentally sensitive and interior areas of the country; and
  - (f) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI T.R. BAALU): (a) and (b) According to the existing Exim Policy, import of naphtha for petrochemical sector is allowed to be imported with certain conditions. Import of F.O. against Special Import Licence has been permitted as per current Exim Policy. The import of LSHS is freely permissible as per existing policy.

(c) and (d) The Ministry of Petroleum and Natural Gas allocates liquid fuel for power plants only on the

recommendation of the Ministry of Power depending on availability. Though naphtha is surplus at present, it will be deficit in future. FO/LSHS is already deficit. Therefore, it is not possible to meet the full demand of liquid fuel for power plants.

(e) and (f) The Ministry of Petroleum and Natural Gas allocates naphtha to various parties in different sectors of the industry only on the recommendation of the concerned administrative Ministry/Department which is responsible for examining the environmental aspects and making recommendations on that basis.
